PRESIDENT'S MESSAGE



Welcome to NYWBA's 75th Anniversary Dinner, where we will honor New York Supreme Court Justice Sherry Klein Heitler with The President's Special Award. NYWBA has had the privilege of Justice Heitler's active and productive participation on its Board for many years, and we commend Justice Heitler on her appointment this year as Administrative Judge,

Civil Matters, New York County.

And what a year it has been for the advancement of women at the U.S. Supreme Court! We were thrilled with the addition last fall of our member Justice Sonia Sotomayor and are ecstatic to see our highest court possibly reach 30% women months soon. This evening we reflect on the remarkable women who dared to forge ahead in this profession as we redouble our commitment and efforts to continue the mission of NYWBA. It is with sadness that a dynamic woman who started it all for NYWBA and countless others, Hon. Florence Perlow Shientag, NYWBA Founder, Past President and Benefactor, cannot be with us this evening leading the charge into the next 75 years. Judge Sheintag was long admired for her strength, intellect, resourcefulness, and determination. We pay tribute to her legacy this evening and appreciate how she has enriched the Association and its mission for years to come.

This past year has been a turning point in our history. While 2009 presented the worst economic downturn in our national economy in nearly three decades, NYWBA membership increased to its highest level yet. Many factors contributed to our growth, including revitalizing our Mentoring Circles program, updating our logo and online presence (thank you Publicity Co-Chair Tamara Lannin for getting us on Linked-In and Facebook), investing in improved technical capabilities to accept electronic payments, manage responses. process renewals, and communicate with our membership in a professional format. As any lawyer can appreciate, introducing new processes and new software in your organization is a necessary but painful process. Introducing this all within the space of months in a volunteer organization transitioning to a new Executive Director and a new Treasurer was downright risky business. I appreciate your patience as we worked through the implementation process. I and the Association are indebted to Past President Elizabeth A. Bryson for taking on the responsibility of managing our technology improvements and to our new Executive Director, Karen Lu, for being the personable, professional, polite, productive and, above all, prompt front office of NYWBA.

At our Annual Dinner last June, we honored Chief Judge of the State of New York Jonathan Lippman, who was warmly introduced by retired Chief Judge Judith Kaye. Following the dinner, an inspired \$100,000 gift became a beacon for the NYWBA Foundation Board. Through the efforts of Vice President Cathy Foti and Director Kay Marmorek, we also held a food drive in June to benefit Food Bank for New York City, with the kind participation and support of numerous courthouses and law firms in Manhattan. A "Virtual Food Drive" was held contemporaneously for monetary donations. The food drive surpassed all goals.

In July, NYWBA held its 14th annual program for summer associates titled "What It's Really Like to Practice Law as a Woman," co-sponsored by the New York City Bar. Many thanks to program leaders Cassandra Porter and Randy Shapiro, Deputy General Counsel, Newsweek, who afterwards accepted the role of Co-Chair of our Mentoring Circles Program. Our 15th annual summer program will be held on June 23, 2010 at City Bar. Sponsors for the reception that follows are always welcome.

In August, NYWBA teamed up with the National Women's Basketball Association (as well as families and friends) for Breast Health Awareness Night at Madison Square Garden. The program was again organized by Director and Past President Jo Ann Douglas. Over the summer, Vice President Cathy Foti assisted me in the selection of leaders for the many committees of our Association, including the two NEW committees established during my term: Intellectual Property, led by Maria Palmese, and Privacy & Cyberspace, led by Patrice Ettinger. The team of Carla Vogel and Annie Ugurlayan to chair our Newsletter Committee may possibly have been the best executive decision made this year. Together with Allison Surcouf, Beth Bryson, and Karen Lu, they have produced informative monthly newsletters with a regularity beyond compare. Possibly as frequent as the Matrimonial & Family Law Committee's substantive monthly meetings, thanks to the efforts of Co-Chairs Briana Denney, Sophie Jacobi, and Judge Andrea Masley.

In September, NYWBA Membership Committee Co-Chairs Jessica Ventarola and Heather Leifer organized our annual Membership Reception at the Skadden Arps firm, where we were graced with remarks from the always inspiring former New York Chief Judge Judith S. Kaye and a special presentation by Family Court Director Jane Schrieber. The special ceremony for Justice Sotomayor at New York Supreme Court with Chief Judge Lippman and Governor Patterson was a momentous occasion in which we shared.

In October, NYWBA kicked off its highly praised Mentoring Circles program at Newsweek with the formation of 10 groups of attorneys and law students to support and mentor each other. Mentoring Circle Program Co-chairs Andrea Vacca and Randy Shapiro rejuvenated the program established by NYWBA in the 1990s. We co-sponsored the annual JALBCA Symposium, which addressed the hot topic of "Gene Patenting". With the inspiration and assistance of our Events Committee Chair Diana Browne, we enjoyed a fun and informative wine tasting at the Sonnenshein firm lead by "Women of the Vine" author Deborah Brenner and a wardrobe networking cocktail party sponsored by Carlyle Collection. October is also when we said goodbye to our beloved founder, Hon. Florence Perlow Shientag, and relived her dynamic life and legal career with NYWBA as smart-

ly summed up by Advisory Board member and Past President Myrna Felder's heartfelt eulogy.

In November, we were oversubscribed for our CLE program touring the New York County Civil Court, organized by our CLE Coordinator Yacine Barry. We were pleased to introduce Judge Eileen Bransten in our "Lunch with a Judge" program organized by Lisa Sokoloff. NYWBA paid tribute to past president Edith Fisch, the first female law professor in New York State, who endowed the Columbia Law School's law library collection. A plaque at Columbia acknowledges her history with NYWBA.

In December, NYWBA Foundation, led by Foundation President Karen Mitchell, hosted a breakfast with former Chief Judge Judith Kaye not only speaking but demonstrating how to "Turn Crisis into Opportunity". NYWBA was also represented on the dais of the New York Women's Agenda annual Star Breakfast, with Jane Fonda receiving the Eleanor Guggenheimer Lifetime Achievement Award presented by Gloria Steinem.

In January, members enjoyed an interesting and insightful "Lunch with a Judge" program – this time with Judge Barbara Kapnick. Our "Lunch with a Judge" programs have been organized by Lisa Sokoloff with the assistance of Kathy Lynch, Co-Chair of our Litigation Committee. Gretchen Schumann organized this year's annual Judges Reception in recognition of the newly elected, re-elected and appointed judges of New York County, with special remarks by Chief Judge Jonathan Lippman.

In February, ADR Co-Cchairs Leona Beane and Andrea Vacca produced a very well-received CLE program titled "ADR in the Courts." NYWBA filled three tables to help celebrate WBASNY 30th Anniversary at the Water Club. NYWBA is proud to be a founding chapter of our statewide organization of women's bar associations, which continues to be a loud voice on issues of importance to women.

In March, International Law & Practice Co-Chairs Rebecca Hollis and Christa Bosch oversaw our sponsorship of the International Women's Day Reception and showing of the documentary "Courting Justice" held at the Court of International Trade.

In April, Elder Law Committee Co-Chairs Kay Marmorek and Miriam Davidson organized a program addressing elder care legal issues with the district attorney involved with the case against Anthony Marshall and his attorney over the estate of Brooke Astor. Following our annual meeting, Myrna Felder moderated a dynamic panel of clerks from the Appellate Division First and Second Departments titled "Everything You Always Wanted to Know About Appellate Practice But Were Afraid To Ask." This was the Fourth Annual CLE on Appellate Practice, conceived of by Lisa Sokoloff.

In May, New York Law Journal published my comments on the significance of the Southern District's decision concerning the patentability of gene-based inventions for its Law Day section. Ethics Committee Co-Chairs Diana McShea and Honorable Barbara Jaffe, along with Matrimonial & Family Law Co-Chairs Briana Denney, Sophie Jacobi and Judge Andrea Masley put on an illustrious CLE panel program entitled "Litigating Under the New Ethics Rules: a Close Look at Rule

3.3 (Client Fraud) and Gender Bias in the Courthouse." The Elder Law Committee organized another helpful program on elder law issues, an important and growing practice area that WBASNY plans to focus on this year. NYWBA again sponsored the Annual Thurgood Marshall Junior Mock Trial Program, the 13th Annual Program held in May. We also participated in the Caren Aronowitz Memorial Diversity Program and Lunch held on June 4th in the Rotunda at 60 Centre Street with the assistance of Membership Committee Co-Chairs.

At the annual WBASNY Convention in May, NYWBA Director and incoming Delegate to WBASNY, Hon. Jacqueline W. Silbermann, received the first annual Judith S. Kaye Access to Justice Award with thunderous applause. Judge Silbermann had a transformative impact across our state through her leadership in the court system as the former Administrative Judge for Matrimonial Matters throughout New York State. In all of her many roles, Judge Silbermann has demonstrated her professionalism, good will, and service to the State of New York and we are privileged to have her talents steering our Association. NYWBA Past President Teresa Schiller was installed as WBASNY President-Elect for 2010-2011 last month, and we look forward to a close working relationship with WBASNY and Teresa.

Let's continue to address the unmet legal needs of women and children in Manhattan and beyond through the New York Women's Bar Association Foundation, a not-for-profit, 501(c)(3) charitable organization. Gifts to the Foundation are tax deductible. Through the Ellerin Scholarship, the Foundation funds judicial internships. With its angel sponsor, the Foundation established a \$100,000 grant over five years to the Feerick Center for Social Justice at Fordham Law School. I thank Karen Mitchell for her leadership of the Foundation this year and wish her continued success in building the Foundation's resources and impacting our community in these important ways.

Let's continue the NYWBA tradition of providing mentoring, networking, leadership and continuing legal education opportunities to advance the status of women in the legal profession. Renew your membership in June and become active in a committee and in a mentoring circle. I thank incoming President, Gretchen Beall Schumann, for her support and wish her an eventful term filled with active members, quality programs, and faithful friends. I look forward to working on the new IP committee and with WBASNY to honor women in the federal judiciary in the coming year and also assist the Attorney Emeritus program established by Chief Judge Lippmann with pro bono training focused on the needs of immigrant children with our Pro Bono Chair, Gail Kempler. Let's go!

Gretchen Beall Schumann is a partner at Cohen Hennessey Bienstock & Rabin P.C., a law firm specializing in complex matrimonial and family law matters, where she has practiced since 2001. A frequent participant on Continuing Legal Education panels, she has lectured for the New York State Bar Association on both procedural and substantive aspects of the Uniform Interstate Family Support Act, and for the E. In 2007, Ms. Beall Schumann co-authored an article for the *New York Law Journal* called "The Alienated Child" with NYWBA Past President Harriet Newman Cohen.

Honorable Sherry Klein Heitler The President's Special Award

Sherry Klein Heitler grew up in the Bronx and has lived in Manhattan for the past 41 years. She attended public schools, Bronx High School of Science, Hunter College (B.A. 1965), New York University (M.A. 1966), and Fordham University School of Law (J,D. 1976). She was admitted to the New York State Bar in January 1977.

During a hiatus between graduate school and law school, she was Assistant Director of Admissions at Long Island University, Brooklyn Campus. One of her primary responsibilities was insuring the diversity of the incoming student body. She was instrumental in developing a special program through which Associate Degree students could matriculate to obtain a B.A.

In 1977, she became a Law Assistant in the Civil Court of the City of New York. In 1979, she founded the law firm of Heitler & Levy, P.C., and taught Family Law at Baruch College, City University of New York. In addition, she was a New York City Civil Court Arbitrator, a Director of the Spingold Foundation, and she served in numerous matters as either a guardian, conservator or referee.

Justice Heitler was elected to the New York City Civil Court for a term beginning in January, 1994. In January 1996, she was designated to sit as an Acting Supreme Court Justice in New York County, and she was elected as a Supreme Court Justice in January 2001. Initially, she sat in a Trial Part. She was assigned to a Matrimonial Part, which involved cases dealing with the status of the divorce, custody, equitable distribution, child support and maintenance issues of the litigants. She sat in a Trial Assignment Part, where she evaluated, settled and assigned cases to trial. Thereafter, she was responsible for conferencing and settling various cases that were brought by or against the City of New York. She then presided over an Individual Assignment Part in which she tried all types of cases and decided motions thereon, including medical malpractice cases, contract cases, personal injury cases and landlord-tenant disputes. She presided over Mental Hygiene Law Article 81 applications and continues to conduct Mental Hygiene hearings at various hospitals in New York City. Such hearings address issues including the administration or withholding of medication, release from or retention by the facility, and electric convulsive therapy.

On January 2, 2007, she was appointed to sit as an Associate Justice on the Appellate Term, Supreme Court, First Department, where she currently reviews criminal and civil cases. In August 2008, she was further assigned to the Center for Complex Litigation, through which she administers all asbestos-related matters in the City of New York, with an inventory of more than 30,000 cases.

In December 2009, she was appointed as Administrative Judge for Civil Matters, First Judicial District.

Justice Heitler has chaired many committees and lectured at many different bar associations and lawyers' groups. She co-chaired the Continuing Legal Education program for the Millennium Women's Bar Convention sponsored by the Women's Bar Association of the State of New York. She is currently an Adjunct Professor of Law at Fordham University School of Law. Because of her strong belief in the value of education, she has employed legal interns from different law schools to work with her as part of their course of study.

She is a member of many professional groups, including Fordham Law Alumni Association (currently serving as Vice President); the New York City Bar; NYCLA; NYWBA (currently serving as a Director); New York State Bar Association; the Jewish Lawyers Guild (currently serving on the Board of Governors); the Judges And Lawyers Breast Cancer Alert and the National Organization for Women. In addition, she also served in a leadership capacity for the United Jewish Appeal, Auxiliary of Tisch Hospital and the Fordham Law School Advisory Panel.



Remembering Honorable Florence Perlow Shientag (1908-2009) ~ NYWBA Founder, Past President and Benefactor ~

New York Women's Bar Association Founder and Past President **Honorable Florence Perlow Shientag** passed away in October 2009 at the age of 101. She led an extraordinarily rich and accomplished life, and she continues to be an inspiration. She championed and supported the Association and women attorneys throughout her 75 years of membership. Through her remarkable bequest of \$250,000 to the NYWBA, she has ensured that we will benefit from her vision and generosity for years to come.



Florence Perlow was born in 1908 and grew up in New York City, the youngest of four children. Her father, who had studied law but never practiced, died in 1935. Her mother went back to school late in life, earning a Ph.D. and practicing as a psychologist.

Judge Shientag received her Bachelor of Science from New York University in 1929 and her LL.B. degree from the New York University School of Law in 1931. After the standard internship then required of aspiring lawyers, she was admitted to the New York bar in 1933.

She began her career as a Law Secretary to the Honorable Fiorello LaGuardia, Mayor of New York City. She adored Mayor LaGuardia and had a variety of duties on his staff, from drafting legislation to investigating appointees for office, to sitting in for the Mayor at hearings. A photo the Mayor signed to Florence has the inscription, "City Hall has not been right since you left."

In the 1930's, New York bar associations did not allow women to be members. In 1934, when she was a recent law graduate and newly admitted, Judge Shientag was one of a handful of women attorneys who gathered together to form the New York Women's Bar Association. In 1935, she was a signatory on the Association's Certificate of Incorporation, which established the NYWBA as a "full service bar association" with all the required incorporation provisions, plus the additional provision to work to "define and elevate the status of women."

In 1937, the New York City Bar finally voted to allow the admission of women, and in 1938 Judge Shientag was in the first group of 13 women lawyers admitted as members.

After she left the Mayor's Office, she became a law clerk for Thomas Dewey, who was then a Special Prosecutor in New York County. In 1941, she was appointed a Judge of the Domestic Relations Court. (These Courts were later restructured and trans¬formed into the NY Family Courts.)

In April 1941, she was elected NYWBA President for 1941-42. The U.S. entered World War II during her term, and she and the NYWBA rose to the occasion. The NYWBA partnered with the American Women's Voluntary Services (whose then-Chairman was NYWBA Past President Jenet Kaplan Brown) to open and staff a clinic to provide urgent legal services to military personnel and their families who could not afford counsel.



The NYWBA also joined with other bar associations to create a joint War Committee, so "attorneys and judges [could] make their contribution toward solving problems caused by the war." (NY Times, 3/19/42.) The committee had more than 75 active members, and Judge Shientag was

named to the 17-person Executive Committee that set policy and prioritized the group's efforts. The War Committee provided legal advice on numerous issues, including the scope of the legal authority of air raid wardens and others who supervised civil defense activities; and the rights of attorneys entering military service to protect their private practices and assets for when they returned from duty, while ensuring their clients receive reprensentation while they were away.

In 1943, she became an Assistant United States Attorney for the Southern District of New York. She was the first female federal prosecutor New York, and one of the first in the country. During her nine years with the U.S. Attorney's Office, she handled a wide variety of civil and criminal matters, including prosecutions for illegal attempts to profiteer during the war, mail fraud cases involving defective products sold across state lines, insurance fraud prosecutions, counterfeiting, etc.

In 1952, Judge Shientag established a solo practice specializing in domestic relations and the representation of artists and others whose First Amendment rights were at risk. She eventually opened additional offices in Florida, London, Rome and Paris.

Over the years, Judge Shientag continued to be active with the NYWBA, New York County Lawyers' Association and New York City Bar, and she chaired committees for each association. She was the first woman elected to the NYCLA Board (1942-49), and she chaired the NYCLA Committee on Domestic Relations, which issued a scathing report in 1952 on the extent of child neglect and abuse, the paucity of social services and shelter available, and the deplorable lack of staff and infrastructure within the Domestic Relations Courts to address these issues.

In 1953, she took on a precedent-setting case involving the French film *La Ronde*, which had been declared "immoral" and banned by the NYS

Board of Regents, which governed film licensing. On behalf of her client, the film's distributor, she argued that the standards used by the Regents were vague and unconstitutional under the First Amendment right to free speech and the Fourteenth Amendment bar on the states unlawfully taking property. A critical issue was whether the government could "pre-censor" a film before it was shown, and this issue was complicated by a 1915 decision in Ohio that had held that movies were not entitled to the protections of the First Amendment. The trial court, Appellate Division and NY Court of Appeals all upheld the ban.

Judge Shientag's petition for *certiorari* to the U.S. Supreme Court was granted, and the case was heard with another matter involving the censorship of the film *M*. She personally briefed and argued the case before the Supreme Court, and in a unanimous opinion by Justice William O. Douglas, the Court struck down the ban and the distinction between movies and other forms of communication.

"Motion pictures are of course a different medium of expression than the public speech, the radio, the stage, the novel, or the magazine. But the First Amendment draws no distinction between the various methods of communicating ideas. ... [E]very writer, actor, or producer, no matter what medium of expression he may use, should be freed from the censor." Superior Films v. Dept. of Education, 346 U.S. 587 (1954).

Protection of the right to freedom of expression was very important to Judge Shientag, not only as a legal matter, but because she was an



artist herself and a patron of the arts. Her home was filled with art, and she was a great friend to many artists, including the sculptor Henry Moore, and most especially Pablo Picasso, whom she knew well and visited regularly. Indeed, when his daughter Maya had a child, Judge Shientag was named godmother. Judge Shientag's paintings and sculptures may not have been as famous as

her friends', but she won an award for one of her sculptures, and being an artist gave her a unique perspective on the potential impact of the law in this field. As a result, she was invited to chair the City Bar's Section on Law and the Arts, which under her leadership held distinguished lectures on the rights of artists, the laws affecting art, new media, etc.

In 1954, Judge Shientag ran a feisty but ultimately unsuccessful campaign to become a member of the NY State Senate. She was endorsed by an extraordinary array of people, including Eleanor Roosevelt, Mayor Robert



Wagner, Margaret Truman, and many other luminaries of the day.

The list of Judge Shientag's honors and service is daunting. By Presidential appointment, she served as a member of the National Commission on Wiretapping and Electronic Surveillance, which the NY Times noted "was created to review Federal and state wiretapping practices [and] is expected to begin looking into the Nixon Administration's use of so-called national security wiretaps, some of which have become a focal point of the Watergate scandals." She was a Director of the United Nations Development Corporation. She was a referee in disciplinary proceedings before the First Department, chaired numerous political campaigns, was a member of corporate boards of directors, and was an invited guest at the inaugurations of many U.S. Presidents.

Judge Shientag also served on the NYS Task Force on Women in the Courts, and when its report was issued, she stated:

"In the fifty years that I have been practicing law, there has been a lessening of the dismissing and intolerant attitude towards women lawyers. This significant improvement is due to the performance and demonstrated ability of women in our profession. Brains have no sex."

An unusually attractive woman, Judge Shientag had strong opinions about women. As she said in a quip to a British tabloid, "Being a career woman is no good if you finish up as an imitation man. I believe women should look, feel, smell like women." On the other hand, she was a mentor to women, as she demonstrated in the same tabloid when she said that solicitors in Britain should "give their briefs [cases] to women barristers whenever possible."

Her mentoring of women lawyers was not limited to lip service, as she often committed resources to ensuring that women succeed. She regularly contributed funds to help defray NYWBA Presidents' expenses and covered the costs of programs and events. She frequently invited women attorneys to a complimentary lunch or dinner to get to know them and give them free advice on how to get ahead in what was still "a man's world."

In 1977, then-President Myrna Felder asked her to organize NYWBA Law Day celebrations. As Ms. Felder recollected:

"Florence, who had practiced in the Inns of Court, suggested a trip to London, which we called "Law Day in Legal London". We had a week without compare. Through her friends and connections, we were received by the Lord Chief Justice:



met with the Lord Mayor of London; watched a trial in the Courts of Chancery and met with the Trial Judge; sat in the House of Commons for debate; traveled to Runnymede for a joint ceremony with the British Bar; were entertained by the Head of the Bar Society and by other members of the British Bar in their homes. On the final evening, Florence had arranged through Senator Jacob Javits for us to host a reception at the United States Embassy to reciprocate the hospitality extended to us during our stay – complete with a caller announcing each honored guest like something out of the movies. It has been thirty-three years since the trip, and it remains as vivid in memory as when we had just returned."

Judge Shientag later established and funded a contest for law school students to write scholarly essays on issues of Constitutional law, with the winning student receiving a \$5,000 scholarship. The scholarship amount was later increased to \$10,000. Many students benefited from the opportunity to research and write on topics that go to the core of our nation's fabric.

When the NYWBA became a founding chapter of WBASNY, Judge Shientag was a great supporter, and she tried to never miss an NYWBA Annual Dinner or WBASNY Annual Convention.

Judge Shientag was a great friend and supporter of the Women's Bar and its members, and she believed in the fair and equal administration of justice. We have all benefited from her influence, and her indomitable spirit and legacy live on in all of us.



FOUNDERS, PAST PRESIDENTS AND ADVISORY COUNCIL

The founders, past Presidents and members of the Advisory Council of the New York Women's Bar Association are a distinguished group. In this section, we identify them and, whenever possible, present highlights of their careers and work with the Association. Due to the passage of time, we do not have biographical information on some of these women, who are so important to our history and future. FOUNDERS

The New York Women's Bar Association was founded in 1934 and incorporated as a not-for-profit bar association in 1935. Eleven women signed the Certificate of Incorporation:

Beatrice Fliegel was a graduate of NYU Law School in 1922.

Doris Silver Freeman

Lillian B. Garrell was admitted to the New York bar in 1933.

Estelle Ruth Grollman was admitted to the New York bar in 1933.

Margaret Fuller Karlin was a graduate of NYU Law School in 1925 and was admitted to the New York bar in 1926. She was married to Ralph Kerbs, also a graduate of NYU Law, Class of 1920. She was a lawyer for and officer of the Tenants Association of New York, which in 1960 (when she was a Vice President) had a membership of 4,000. She was President of the NYU Law Alumni Association during the 1950's and 1960's. After she passed away in 1982, a scholarship was established in her name at NYU Law School.

Minnie Kelter (Goldberg) was a graduate of Hunter College and NYU Law School. A founder of the NYWBA, she went on to become a Director of the Bronx Women's Bar Association, President of the Bronx Professional and Business Women's Group, and a member of the Ulster County Bar Association. Her husband Maurice Goldberg was an Assistant Attorney General for NYS. She moved from New York City to Woodstock in 1948, and she passed away in 1960.

Lauretta Rose was admitted to the New York bar in 1932. Starting in the mid-1930's, she served as a referee in the determination of real estate property rights and transfers.

Hilda G. Schwartz, Founder and Past President (see below)

Florence Perlow Shientag (Frankel), Founder and Past President (see below)

Freda Spinard (Baileson) was a 1922 graduate of NYU Law School (LLB). After serving as a Founder of NYWBA, Ms. Spinard was elected President of the Queens Women's Bar Association in January 1936. She passed away in 1947.

Rose Lehman Stein, Founder and Past President (see below).

PAST PRESIDENTS

1934-38 - Rose Lehman Stein Stein was a Founder and served for three terms as NYWBA's first President. She graduated from NYU Law School in 1922 and was admitted to the New York bar in 1923. She received an LL.M. from NYU Law School in



1925. Ms. Stein became the first female president of the New York University Club in 1922 and the first female president of the NYU Law Alumni Association in 1955. She was also active with the New York

County Lawyers' Association, serving on the Legal Education and Admission to the Bar Committee and chairing the Revision of the NYS Constitution Committee in the early 1960's. She practiced law for more than 60 years, until she passed away in 1985.

1938-39 - Jenet Kaplan Brown earned her law degree from Brooklyn Law School and was admitted to the bar in 1929. During her Presidency, Ms. Brown and then-Secretary Jeannette Harris were featured in a *New York Times* article about the NYWBA's resolution urging the nomination of women Supreme Court Justices in the First Judicial District and the appointment of Judge Florence E. Allen of the Federal Circuit Court of Appeals to the U.S. Supreme Court. In 1942, during World War II, Ms. Brown was Chairman of American Women's Voluntary Services, which partnered with the NYWBA to open and staff a clinic to provide urgent legal services to military personnel and their families who could not afford counsel.

1939-40 - Hon. Hilda G. Schwartz was a Founder, President, Vice President and the first Secretary of the NYWBA. Valedictorian of her high school, she attended NYU for both undergraduate and law school. At a time when there was crushing discrimi-



nation against women, she was the first Director of Finance for New York City, served as Secretary of the Board of Estimate, and was a judge for 24 years. She was also active with the New York County Lawyers' Association, serving on the Professional Ethics Committee in the 1960's. She retired as a Justice of the Supreme Court in 1983, at 76. She was married to lawyer Herman Schwartz, and they had a practice together. They lived in Greenwich Village and helped found the Village Temple. She passed away in 1998.

1940-41 - Lillian M. Kooperstein, born on the Lower East Side to an Orthodox Jewish family, was admitted to practice in 1925. Upon her graduation from NYU Law School, she obtained a clerkship at a law office, which was then a prerequisite to sit for the



bar. Upon passing the bar, she opened a law office with her brother, Moses, and practiced matrimonial law in the 1920's and 1930's. During World War II and for 30 years thereafter, she was a sole practitioner. Married in 1949 to a law school classmate, Joseph Goldberg, she shared office space with her husband on lower Broadway. She also sat as an Administrative Law Judge during the late 1980's and early 1990's – well into her own early 90's! She also served as a President of the Council of Jewish Women. She passed away in 1998

1941-42 - Hon. Florence Perlow Shientag -Judge Shientag was a founding member and President of the Association. (See full profile above.)



1942-43 - Isabel Joffe graduated from Brooklyn Law School and was admitted to the New York bar in 1928. In addition to her work with the NYWBA, she was an active member of the New York County Lawyers' Association, serving on the Military Jurisprudence Committee. She passed away in 1961.

1943-44 - Marie C. Connolly graduated from Fordham Law School in 1933 and was admitted to the New York bar in 1934. She held many positions on the Board before she was elected President of the Association.

1944-45 - Adelaide Burkan Bodow was born in 1912, and she graduated from NYU and NYU Law School, where she was the only woman in her class. She was admitted in 1940 and practiced law at Schwartz & Froehlich with her uncle, Nat Burkan, a founder of the American Society of Composers, Authors and Publishers (ASCAP). They represented such notables as Charlie Chaplin, Mary Pickford and Douglas Fairbanks, and Al Jolson. Among other accomplishments, she persuaded the NY Chief Judge to speak at a NYWBA event, which brought recognition in law publications and increased the stature of the Association. She was active in the NYWBA for decades, chairing the Judiciary Committee in the early 1960's. She married Edward L. Bodow in 1939, had three children between 1950 and 1955, and then worked part-time at Schwartz & Froehlich for the remainder of her career.

1945-47 - Jeannette Harris served for 10 years on the staff of the NY Attorney General's Office, Labor Bureau, before she went into private practice in 1944. She held several positions in the NYWBA., and she spoke out publicly on the importance of ensuring that women were able to continue to retain employment after the end of World War II. After the war, she testified on child labor laws and in favor of equal rights for women in employment. In the late 1940's and early 1950's, she was an officer of the Women's Trade Union League. During the mid- to late-1950's she was President of the New York Workmen's Compensation Bar Association.

1947-49 - Esther Glantz served as Secretary for three years and Vice President prior to her Presidency. She graduated from the Washington Square College of NYU in 1934 and NYU Law School in 1936. She was a partner of Joseph F. McCloy in the law firm of McCloy and Glantz. She married Dr. Chester Kremer, a professor of chemistry at CUNY, in 1951, and they had two children. She was also active in New York County Lawyers and the City Bar, chairing committees for both associations.

1949-51 - Hon. Frieda Levin Lorber graduated summa cum laude from NYU and received her law degree from NYU Law School in 1938. She received an LL.M. from Columbia Law School in Comparative and International Law School in 1959. She worked



for the Department of Investigations of the City of New York, served as a judge for Small Claims Court, worked with Jewish Philanthropies, and was a member of the International Federation of Women Lawyers and a representative to the United Nations Human Rights Community. She also chaired the Law Alumni Association at NYU Law School. She studied piano and voice at the Institute of Musical Art (now Julliard), sang as a mezzo-soprano with the chorus of the Metropolitan Opera in the 1920's and was a member of the New York Oratorio Society. She passed away in 1976.

1951-53 - Julia Perles graduated from Brooklyn Law School in 1937. She is widely considered to have played the leading role as chair of the committee that brought about the passage of New York State's equitable distribution law, which went into effect in 1980.



This law brought a revolutionary change in the practice of matrimonial law and in the rights of marital partners. Until her death in 1998, Ms. Perles was affiliated with Phillips Nizer Benjamin Krim and Ballon, LLP, where she became a partner in 1970 and headed the firm's matrimonial practice. Before that, she was an associate at Schwartz & Froehlich from 1942 to 1952, and then a partner at Greenbaum Wolff & Ernst. Ms. Perles was also a fellow of the American Academy of Matrimonial Lawyers and a member of the Dirty Thirty, an organization of American lawyers who were prominent in the field of matrimonial law.

1953-55 - Norah K. Donovan graduated from NYU Law School in 1945 and was admitted in 1946. She served for many years as the attorney in charge of copyright matters for the American Broadcasting Company. She was also an officer and Corporate



Secretary of the Audio and Video Products Corporation during the 1950's. She held numerous positions in the NYWBA. After her Presidency, she was appointed to chair several NYCLA Committees, including the Municipal Court Committee, the Committee on Discipline, and the Committee on the Unlawful Practice of Law. She was also involved in charitable works.

1955-57 - Mary R. Cowell Ross graduated from Kansas City School of Law and received her LLB *cum laude* from Southern Law University. Now retired, she had a solo practice in New York for more than 30 years. Before that, she was with Royall,



Koegel and Rogers from 1946 to 1961, specializing in wills, trusts and estates. From 1940 to 1946, Ms. Ross was in Washington D.C., where she worked for a number of federal agencies and was affiliated with the general practice firm of Cromelin, Townsend and Kirkland. She became active in the NYWBA in 1948 and served as a Vice President for two terms, Corresponding Secretary, Director, member of the Advisory Council, and member of the Judiciary, By-Laws, Legislation, and Equal Opportunities for Women Committees. Until recently, she was also active in other professional organizations, including the National Association of Women Lawyers and the New York City Bar.

1957-58 - Anna Oberwager received her bachelor's and master's degrees from NYU in 1909 and 1910. In later years, she studied at Fordham University. She was admitted to the bar in 1916. She and her husband, Hon. Charles A. Oberwager, a New York City



magistrate, were law partners, and they had two children. Later, their son Edwin served as a Justice of the New York Supreme Court. Ms. Oberwager passed away in 1987.

1958-59 - Norma Z. Paige is Chairman Emeritus of Astronautics Corporation of America's Board of Directors. Since Astronautics was founded in 1959, she has held various offices, including Executive Vice President and Chairman of the Board of



Directors until 2001. From 1988 to 2001, she also served Kearfott

Guidance & Navigation Corporation as its Executive Vice President and as a member of its Board of Directors. Ms. Paige received her BA and J.D. degrees from NYU and is admitted to the bars of the United States Supreme Court and New York State. She was a partner in the law firm of Paige & Paige. She is the recipient of numerous awards, including the Jabotinsky Award, presented by Menachem Begin, former Prime Minister of Israel. Ms. Paige has two daughters and sonsin-law, all of whom are attorneys.

1959-60 - Lucille M. Gannon was associated with Sherman & Sterling. In the year after her Presidency, she chaired the NYWBA Legal Education Committee. She was active in the NYWBA for decades, serving as Treasurer, in other Officer posi-



tions, on the Board, and as the Chair of many committees. She passed away in 1978.

1960-61 - Marie Mallot was born in 1921. She worked as a legal secretary at Kurzman, Karelsen & Frank in the early 1940's. Noticing that she was extremely bright, several attorneys at the firm encouraged her to attend law school at night, which she did. She was the only woman in her class when she graduated from Fordham Law School in 1946, and she was admitted to the bar in 1947. In addition to serving as a NYWBA Officer, Director and Committee Chair, she was active with New York County Lawyers' Association, chairing several committees over the years. Ms. Mallot spent her entire legal career practicing estates law at Kurzman, Karelsen & Frank. She retired in 1976, but she continued doing some work for the firm into her retirement

1961-62 - Hon. Florence Raider Zimmerman graduated from Hunter College in 1937 and from New York Law School in 1941, and she was admitted to the bar in 1941. During college, she interned with NYC Deputy License Commissioner Dorothy



Kenyon, and she later became an attorney for the New York City Rent and Housing Administration. An expert on rent control, she argued before the NY Court of Appeals on a precedent-setting case involving the application of rent control to properties that were claimed to be "hotels." She was admitted to the U.S. Supreme Court in 1954. She was also a NYCLA Committee Chair. She was counsel for the Hunter College Alumnae Association. She was appointed a NYC Civil Court Judge in 1971. Now retired, Judge Zimmerman sends her affectionate regards on the Association's 75th Anniversary.

1962-63 - Ethel F. Beaver graduated from NYU Law School in 1951 and was admitted to the bar later the same year. She was a member of the firm Korkus & Korkus and was married to Dr. Kurt Berliner, a cardiologist. She served as a NYWBA Officer, Director and Committee Chair.

1963-64 - Hon. Freda Silbowitz was a *Phi Beta Kappa* graduate of Hunter College and received her law degree from Columbia Law School in 1937. She was admitted to the New York bar in 1938. Before serving as President, she was involved in her law



practice and served on the bench. During her tenure with the NYWBA, she chaired several Committees and organized the United Nations Reception for members of the British Bar who traveled to the United States to exchange knowledge and insights about the two countries' respective legal systems.

1964-65 - Shirley P. Thau was admitted to the bar in 1947, having graduated in 1946 from NYU Law School, and Hunter College before that. Over the years, she practiced in many areas, including international law, trusts and estates, and litigation. She became a senior partner in the law firm of Wolf Popper. When she left that firm, she became a principal at Gruen, Muskin & Thau, which she left in 1986. She was also active with other bar associations, and she chaired several NYCLA Committees. She later retired to Florida.

1965-66 - Bessie D. Goldberg served as President of both the NYWBA and the Nassau/Suffolk County Women's Bar Association. She was an attorney for the Legal Aid Society and rose to the position of Attorney-in-Charge of its Rockaway Office. She and her husband, Hyman Goldberg, had four children, as well as grandchildren and great-grandchildren. She passed away in 2007.

1966-67 - Fannie J. Klein was admitted to the bar in 1928. In addition to lecturing and authoring several legal works, she received numerous awards. An expert on court reform, Mrs. Klein was most thrilled when she was named the first woman Professor of



the NYU Law School in 1958. She was also the librarian, assistant director, and associate director of NYU School of Law's Institute of Judicial Administration, which was established in 1952 to promote greater efficiency in court administration throughout the nation. Ms. Klein was a member of the Judicial Selection Committee for the Supreme Court in New York City in 1968. After 1975, she practiced law in Surrogate's Court and Supreme Court, where she often served as a guardian, conservator and referee. She passed away in 1984.

1967-68 - Marie Whitesell Balboa was active in the Association for many years. In the 1960's, she was a Committee Chair, Director and Officer. Among other roles, she represented the NYWBA in its relationships with other bar associations.

1968-69 - Doris Sassower – During her tenure as President, Ms. Sassower was a proponent of programs that would increase the number of women entering law school. She cited statistics reflecting that women made up fifty percent of the law school enrollment in some European countries, while our own law schools at the time could boast only minimal percentages of women. She also remarked on the low appointment rate of women to judgeships, which was less than one percent at the time.

1969-70 - Hon. Betty Weinberg Ellerin was the first woman appoint-

ed to the First Department and the first female Presiding Justice of that Court. Elected to the bench in 1976, she was the first woman to serve as Deputy Chief Administrative Judge of New York State. She is the Chair of the NYS Judicial Committee on Women in



the Courts, Vice Chair of the NYS Advisory Committee on Judicial Ethics, and Vice Chair of the First Department Committee on Character and Fitness. She was President of the National Association of Women Judges and is a Founder and Director of WBASNY and JALBCA. Among her innumerable awards are the NYWBA President's Special Award (twice); the WBASNY Betty Weinberg Ellerin Mentoring Award, which was established in her honor; the NYS Association of Women Judges Leadership Award, the ABA Margaret Brent Award, and the Florence E. Allen Award. Justice Ellerin and Milton H. Ellerin have three children and three adorable grandchildren.

1970-71 - Dr. Edith Lond Fisch was confined to a wheelchair due to childhood polio, but she did not let that limit her accomplishments. She earned a B.S. in chemistry from Brooklyn College, was the first person to earn all degrees awarded by Columbia Law School (LL.B., LL.M. and Jur.Sc.D.), and the first



woman to earn a Jur.Sc.D. from Columbia. In private practice, she focused on trusts and estates. In 1959 she published *Fisch on New York Evidence*, which is widely used by the bench and bar and as a law school text. In addition to nearly forty law review articles, she authored *The Cy Pres Doctrine in the United States* (1951) and *Charities and Charitable Foundations* (1974). Appointed a Assistant Professor at New York Law School in 1963, she was the school's first female law professor. She later returned to private practice, and she passed away in 2006. In 2009, Columbia unveiled a plaque honoring Dr. Fisch, who bequeathed \$1.8 million to endow the Law Library Collection in perpetuity.

1971-72 - Mathilda Miller Cuneo graduated from NYU Law School in 1926 and was admitted in 1928. She was the first woman member of the Bronx County Bar Association in 1945 and a Trustee and benefactor of the Bronx-Riverdale YM-YWHA. Ms. Cuneo chaired the Matrimonial Law Committee, and in 1966



undertook a special but unfulfilled project to enact legislation allowing for divorce if the plaintiff had an illegitimate child after living apart from his/her spouse five or more years. *The New York Times* noted that "thousands of families ... would be assisted by [this] amendment" and that this ""very important ground for divorce' would remove the "stigma of illegitimacy from thousands of children, many of whom are not aware that their parents are not married." In later years, she also practiced real estate law. In 1991, she was honored by NYU Law School when it celebrated the 100th anniversary of its admission of women. She passed away in 1997.

1972-73 - Hon. Harriet Gair graduated from New York University School of Law, receiving her LLB in 1940. In 1945, she became a partner at Gair and Gair and was in full charge of the management of the firm. From 1976 to 1981, she served as an elected



Town Justice in Putnam County. During Judge Gair's term on the bench, she was engaged in many areas of civil and criminal law, and was regarded as a firm but fair Justice. In addition, she served as President of the Putnam Valley Free Library Board of Trustees, the Mid-Hudson Library System, and as a member of the Town Board of Putnam Valley. With Judge Gair's continuing interest in Judaism, she devoted herself to worthy Jewish causes and Jewish jurisprudence, and was honored by the Institute of Jewish Humanities. Her son Anthony Gair is a NYWBA sponsor and a partner in the successor firm of Gair, Gair, Conason, Steigman, Mackauf, Bloom & Rubinowitz.

1973-74 - Joan Ellenbogen graduated from NYU Law School and was admitted to practice in 1965. With Marcia Goldstein, she formed Ellenbogen and Goldstein, P.C., with a practice limited to matrimonial and family law. She was a fellow of the American Academy of Matrimonial Lawyers, a Diplomate in the



American College of Family Trial Lawyers, a member of the Joint Committee on Judicial Administration, a member of the Commission on Judicial Nominations to the Court of Appeals, and the first woman to chair the New York City Bar's Executive Committee. She was a member of the First Department Disciplinary Committee, served on the Board of Trustees of the Legal Aid Society, and was listed in *Best Lawyers in America*. She was a Founder and the first President of WBASNY, and the WBASNY Founders Award has been renamed in her honor. After a valiant struggle with pancreatic cancer, she passed away in 2001.

1974-75 - Sheila L. Birnbaum is a partner at Skadden Arps, Slate, Meagher & Flom LLP, where she heads the Complex Mass Tort and Insurance Group. She has successfully argued appeals throughout the country and before the U.S. Supreme Court. She has taught at NYU and Fordham Law



Schools, is co-author of the *Practitioner's Guide to Litigating Insurance Coverage Actions*, and has regular columns in the *New York Law Journal* and *National Law Journal*. In 1997, then Chief Justice Rehnquist appointed her to the Judicial Conference Advisory Committee on Rules and Civil Procedure. Former Chief Judge Judith Kaye appointed her Chair of the Commission on Fiduciary Appointments. She was also the first President of JALBCA. She has received numerous awards, including the ABA Margaret Brent Achievement Award, and has been named by the *National Law Journal*, *Fortune* and *Crain's New York Business* as one of the top members of the legal profession and most influential women in business.

1975-76 - Florence B. Donohue was born in New York City in 1919. After becoming a widow, she moved with her five children to Louisville, Kentucky, where she attended the University of Louisville Law School, graduating *magna cum laude*. She returned to New York, was admitted to the bar in 1960. She



obtained a master's degree in taxation at NYU Law School and became the editor of Prentice Hall's *Federal Tax Guide* and a sought after tax expert on news programs. Florence spent her later years living in her beloved Montauk, Long Island home. She passed away June 23, 2009.

1976-77 - Myrna Felder is a graduate of NYU Law School and was admitted to the New York bar in 1971. She is a popular lecturer for all major bar associations. As chair of the NYS Bar Association's Committee on Courts of Appellate Jurisdiction, Ms.



Felder organized the State Bar's CLE program on Appellate Practice in 1989, which is presented bi-annually in each of the four judicial departments. She regularly teaches at the Summer Judicial Seminars, and throughout the year in training sessions for the Matrimonial Judges and their staff, newly elected Judges, Court Attorneys and Special Referees. For the New York Women's Bar Association, she served on our Board of Directors, then as Secretary and Treasurer, before serving as President. The next few years were devoted to working to establish the Women's Bar Association of the State of New York, where after serving on the Board of Directors, she was President in 1986-87. Ms. Felder also organized WBASNY's Matrimonial Committee in 1983 - its first substantive committee - and she remains a resource at both the state and local level to this day.

1977-78 - Beverly Gross is a labor lawyer whose practice is limited to labor arbitration and mediation, including ERISA. She has been labor and benefits counsel to NY Telephone Co.; General Counsel District Council 37 (American Federation of State,



County and Municipal Workers); General Counsel, New York State Division of Human Rights; Associate General Counsel, New York City Commission on Human Rights; and an Assistant Corporation Counsel of New York City. She has extensive experience in arbitration and mediation, as well as with the NYS Public Employment Relations Board and Civilian Complaint Review Board. She graduated from NYU Law School in 1968 and joined the NYWBA the same year. She also represented the NYWBA on the Second Circuit Panel on Admissions and Grievances.

1978-79 - Marcia C. Goldstein is a graduate of NYU Law and was admitted in 1967. While President of the NYWBA, she was Associate General Counsel at Lehman Bros. Kuhn Loeb. With Joan Ellenbogen, she formed Ellenbogen and Goldstein, P.C., practic-



ing matrimonial and family law. She was a founding member of WBASNY and served as a WBASNY Director (1980-85). Ms. Goldstein has chaired the New York City Bar Matrimonial Committee; chaired the Executive Committee of the New York State Bar, Family Law Section; co-chaired the Subcommittee on Equitable Distribution; and is a member of the American Bar Association, Family Law Section. Ms. Goldstein was appointed by former Chief Judge Judith Kaye to serve as a member of the Matrimonial Commission of the State of New York. Presently, she is practicing part-time.

1979-80 - Andrea Hyde is a partner at Putney, Twombly, Hall & Hirson LLP, practicing in the field of trusts and estates. She has served on the Executive Committee of the Trusts and Estates Law Section of the NYSBA and is currently an advisor to the NY



EPTL-SCPA Legislative Advisory Committee. While serving as a member of this Committee, it formulated the legislation that later became the Principal and Income Act (2001). She has lectured widely in the areas of wills, trusts and estates, including for CLE programs presented by the NYWBA and other bar associations. A graduate of St. John's Law School, Ms. Hyde is a fellow of the American College of Trust and Estate Counsel and is listed in *Best Lawyers in America*.

1980-81 - Diane S. Wilner graduated *magna cum laude* from Brooklyn Law School, where she was a Law Review editor. After being an associate of Skadden Arps, she and three colleagues formed its first spin-off. Later, she founded Wilner & Associates,



P.C., which represents Fortune 500 corporations and institutions in diverse areas, including employment, products liability, insurance and commercial litigation. Ms. Wilner is known for litigating complex cases at the cutting edge, including successfully trying the first case of a physician with AIDS, and in which there were cameras in the court-room throughout the trial. As NYWBA President, she continued the smooth transition with the newly-founded WBASNY and furthered the NYWBA's tireless efforts to open doors for women attorneys.

1981 - Hon. Karla Moskowitz is an Associate Justice of the Appellate Division, First Department and has served on the bench since 1982. She cochaired numerous NYWBA committees and was the founder and Chairperson of the Referral Service



(1975-77). A breast cancer survivor, Justice Moskowitz was a founder and past Co-President of JALBCA. She also served as President of both the New York State Association of Women Judges and the National Association of Women Judges. She received her BA *cum laude* from Alfred University and her J.D. from Columbia Law School. Among her many awards are the Edith I. Spivak Award from NYCLA's Women's Rights Committee and WBASNY's Founder's Award. She is a frequent lecturer and author. She and her husband, attorney and NYWBA member Marvin Moskowitz, have two children and four grandchildren.

1981-82 - Irene S. Sullivan is a graduate of Mount Holyoke College, NYU and Fordham University School of Law. She began her legal career in 1976 at Skadden, Arps, where she handled a wide variety of commercial matters, with an emphasis on antitrust



and securities litigation in federal courts and insurance coverage disputes. She was a partner from 1982 to 2003 and served for several years as Head of the New York office. Ms. Sullivan was President of both NYWBA and WBASNY. the nation and a model for the country. She is a co-author of legislation, including NY's Rape Shield Law. She was appointed to the NYC Criminal Court in 1983 and thereafter to the NY Supreme Court and Court of Claims, presiding over many high-profile cases. A committed community advocate, she has served on many boards, adopted a public school, and volunteered in the New Orleans criminal justice system for six months after Hurricane Katrina. She is the author of 25 to Life. She was awarded the NYWBA's Florence Allen Award in 2003. Married for 42 years, she is mother of two grown sons.

1983-84 - Madeline C. Stoller received her J.D. in 1976 from Fordham University School of Law. She was admitted to the New York Bar in 1977 and thereafter to the US Supreme Court. She has been a member of the New York City Bar since 1980 and has



served as Chair, Product Liability Committee; Chair, Lawyers in Transition Committee; Chair, Public Service Resource Center; Member, Executive Committee and Nominating Committee; Delegate to the ABA House of Delegates; and Director on the City Bar Fund. In addition to serving on NYWBA and WBASNY Boards and Committees, she also served on the City Bar's Executive Committee and other committees and as a Vice President of the City Bar Fund. She lives with her partner, Donna Dennis, and their three-year-old son, Jack.

1985-86 - Harriet Newman Cohen graduated from Barnard College (BA Latin, 1952) and Bryn Mawr (MA Latin, 1953). After teaching and raising four daughters, she graduated in 1974 from Brooklyn Law School, where she was an editor of the Law

She remains in active practice in her firm, Cohen Hennessey Bienstock & Rabin P.C.

1986-87 - Anne T. Schwab graduated from St. John's University School of Law in 1978. From 1980 to 1988, she was an associate in the litigation department at, Emmet, Marvin & Martin. From 1989 to 1997, she was a Senior Counsel in the Legal



Department of The Bank of New York, practicing in the litigation group and then in the commercial lending/private banking group. In 1997, she joined the legal department of Deutsche Bank, where she is presently a member of the Private Banking practice group. In 2004, she was made a Managing Director of the Bank.

2002-03 – Heather Martínez Zona manages a real estate investment company, handling properties in New York, New Hampshire and California. Previously Ms. Zona was a litigation associate at New York law firms representing policyholders in dis-



putes with their insurance companies. Ms. Zona served the NYWBA in a variety of capacities, including President, Vice President, Recording Secretary, Director and Committee Chair. She organized a number of programs for the Association, including "Tips for New Lawyers," "Take Our Daughters to Work Day" at the Second Circuit, and "What It's (Really) Like to Practice Law in NYC as a Woman" (cosponsored by the City Bar). Ms. Zona received her J.D. from the University of Michigan Law School, where she was awarded the Jane L. Mixer Award for Social Justice.

2003-05 – Elizabeth A. Bryson is a litigator and appellate attorney. As Associate General Counsel and then Corporate Vice President of New York Life, she supervised complex litigation and managed the privacy, business continuity and crisis management

Hon. Sheri Roman is an Associate Justice of the Appellate Division,

Second Department, and was a Queens County Supreme Court Justice for 14 years. At the Bronx DA's Office, she was Chief of the Major Offense Bureau, Acting Chief of the Homicide Bureau, Chief of the Litigation Training Bureau, and in the Appeals



Bureau. A Phi Beta Kappa graduate of SUNY Buffalo, she received her LL.M. in Criminal Justice from NYU and J.D. from Georgetown. She served on the NYWBA Board as a Director and Vice President and chaired the Judiciary and Criminal Law Committees. She has been active in other bar and civic organizations, including the National Association of Women Judges (VP, Secretary); NYS Association of Women Judges (VP; Chair, Law School Outreach); the Samuel Field YM-YWHA (Board); Queens County Women's Bar Association; NYC Supreme Court Justices Association (Director, Corresponding Secretary); Criminal Court Judges Association (VP); NYC Criminal Court Bias Committee; and Queens County Gender Fairness Committee (Chair). Justice Roman is married and has two children.

Hon. Felice K. Shea is a retired Justice of the Supreme Court of New York State. She served as a NYWBA Vice President, a member of its Board of Directors for 17 years, and as an active member and Chair of Association Committees. Before election to

NYWBA'S FIRST 75 YEARS ~ SEEKING THE FAIR AND EQUAL ADMINISTRATION OF JUSTICE

As can be seen from the profiles of our Founders, Presidents and Advisory Council members, the NYWBA has an incredibly rich and vibrant history. During the 75th Anniversary Dinner, the NYWBA will debut a special slide show with many photographs and documents from our first 75 years. NYWBA is Formed (1934-1935) - The New York Women's Bar Association was formed in 1934 after several of our founders were denied membership by the New York City Bar Association. When Hilda G. Schwartz (later Judge Schwartz) applied, she was turned down and told, "We have no restroom facilities for women." Our 1935 Certificate of Incorporation, filed on Ms. Schwartz's blue backs, contained all of the provisions found in the City Bar's Certificate, including all of the "purpose" provisions of a full service bar association - with a single additional provision, which reads, "To define and elevate the status of women."

NYWBA's First Membership Reception (1936)

The NYWBA held its first annual reception on May 25, 1936, welcoming 50 new women lawyers. The event was at the George Washington Hotel, as women were then not welcome at any bar association facilities.

During World War II, the NYWBA was very active. Among other accomplishments, it started a legal clinic for military personnel and their families who could not afford counsel, and it worked with other bar associations to provide legal advice on complex legal issues caused by the war. Demand for the legal clinic was so great that its hours were expanded to be includes Saturdays and evenings.

Although she graduated near the top of her class at NYU Law School, Fannie Klein was told in 1942 by a prospective (male) employer, "The boys are away at war, and we're scraping the bottom of the barrel." Ms. Klein went on to become an accomplished litigator and expert on court reform, the first female Professor at NYU Law School, and a President of the NYWBA.

"Men-Only" Bar Associations Begin to See the Light (1937)

In 1937, the New York City Bar allowed the NYWBA to hold its second reception at its building, and more than 200 women gathered for a triumphant celebration of the first time in sixty-eight years when women were allowed in that facility on equal terms with men. The following May, the City Bar voted to accept women members, and then-President Stein expressed the hope that "other bar associations which still stubbornly keep out a large group of lawyers because of their sex will do likewise." Many of our Founders were among the first group of thirteen women sworn in as City Bar members.

Seeking Parity in Judicial Appointments

On May 18, 1947, during the NYWBA annual luncheon, Magistrate Anna M. Kross charged that there was discrimination against women lawyers in the courts of this area. A New York Times article quoted Magistrate Kross: "There has never been a woman on the Federal district court bench," she said, "or the surrogate's court. Surely the latter, which was formerly known as the court for widows and orphans, is a place where women would be ideally suited to hold office." She added that in Queens County there never has been a woman lawyer on the court bench or in the district attorney's office. Additionally, it was reported that a nation-wide committee had been formed to fight for the principle of jury service for women in all states on an equal basis with men - in fourteen states, women cannot serve on juries and in fifteen others the right to serve is optional.

NYWBA on Domestic Violence

The NYWBA co-sponsored the Second Annual Conference on the Legal Rights of Battered Women in 1982. Participants represented thirteen counties and included assistant district attorneys, legal services and legal aid attorneys, law students, probation officers, social workers, and volunteers in shelters and on hotlines for battered women. Throughout the 1980's, when clinics or other programs for battered women were practically nonexistent, the Association continued to train attorneys to provide these services, often pro bono. The NYWBA and WBASNY have been leaders on the issue of domestic violence for decades.



The NYWBA was the major force behind the decision to establish the Women's Bar Association of the State of New York in 1980. NYWBA Past President Joan Ellenbogen was WBASNY's first President, and many NYWBA members have served as WBASNY Presidents, Officers and Directors.

JALBCA (1992) - The Judges and Lawyers Breast Cancer Alert is an important part of the Association's history. It was formed in 1992 by lawyers and judges who wanted to focus the legal community's response to the breast cancer epidemic among women and to provide information and resources to women in the community. This commitment continues to this day, with NYWBA members serving as JALBCA Co-Presidents, on the JALBCA Board, and as JALBCA project leaders.


