Celebrating Women's History Month

I was elected to the one-year term as president of the NYWBA in 1985, and I served from 1985–1986. As a matrimonial lawyer, I had been intimately involved, at the end of the 1970s and into the early 1980s, with the negotiations for and the enactment of the reforms in matrimonial law, known as the "Equitable Distribution Law." The new law brought relief to women (and children). Under the old law, women were not recognized as the important partners to their husbands that they were. Rather, they were held down in an inferior position, not unlike children, with respect to the finances of the marriage. With the advent of the Equitable Distribution Law in 1980, title no longer controlled, and factors were listed which acknowledged that the unremunerated work on the home front was equally valuable to the breadwinner's work in the paid work force. In particular, women's "contributions" to their husband's, and women's sacrifices of their own careers to promote their husbands' careers and to tend to the household and the children became valued and warranted a price tag. In addition, women against whom fault grounds, such as adultery, had been alleged were no longer automatically disentitled from spousal support if there was a finding of fault, as they had been under the old law. We also fought for higher levels of child support, arguing that children should not be left with the "crumbs" after divorce.

I served on Governor Mario M. Cuomo's prestigious Child Support Guidelines Committee under the leaders of his Women's Division, including Ronnie M. Eldridge, Judith Avner and Carol H. Lefcourt. With their leadership, New York State became the best state for child support: Our guidelines were the highest, the best and lasted the longest (until age 21). Our very active Matrimonial Committee, which I chaired prior to being elected President of the NYWBA, prepared memos and sent our members to present scholarly and impassioned testimony at the public hearings which were being held on a regular basis as the laws were evolving. Our voice was heard and heeded. Our presenters were known as the defenders of women and children. The Governor, the Legislature and the Judges read our materials, listened to our testimony and incorporated our scholarship and conclusions into their executive orders, legislation and judicial decisions.

I particularly want to remember the strength, wisdom and support of **Carol H. Lefcourt**, a prominent New York City lawyer and women's rights advocate, who worked closely with me and was a strong supporter of my presidency. Carol drafted much of New York's landmark child-support legislation. Carol was the overall editor of the important treatise, "Women and the Law" (Clark-Boardman, 1984), which was cited by the Association of American Publishers as the best law book of that year. Tragically, in 1991 when she was 47, Carol was stricken by an aggressive and merciless medial breast cancer which took her life.

I also worked very closely with **Adria S. Hillman**, co-authoring numerous scholarly articles, starting in 1984 with our analysis of 70 select cases under the Equitable Distribution Law from 1981-1984, a work which was cited in the early years of the Equitable Distribution Law by all three branches of the government.

I was proud when 25 years later, my law partner, **Gretchen Beall Schumann**, was elected to the presidency of the NYWBA in 2010, carrying on the proud tradition of leadership of the NYWBA. In 2015, she became the president of the New York Women's Bar Association Foundation, a position she holds with distinction.

I continue to honor and respect the NYWBA and the work we do on behalf of the rights of women and children.

I served as President for a brief time in 1982. Just after my induction, the Democratic Party selected me to be its candidate for Civil Court in Manhattan. Because I could not present NYWBA's positions on any political issues, I stepped down and president-elect **Martha E. Gifford** stepped up.

But that was just a small part of my participation in NYWBA and the then-newly-formed WBASNY.

We formed a legal referral service for women and a committee to expand child care opportunities, and helped expand our work with other bar associations on issues of importance to us such as a fairer divorce law with required interim support and more equality in distribution of assets. We noticed the paucity of women on the bench and organized a program to educate about the practicalities and to meet the decision makers.

As with all NYWBA projects, the "we" is inclusive and refers to the wonderful NYWBA members who worked together and became friends for life. Through those years I received more support from NYWBA than the time and effort I contributed to it.

Greetings from Hon. Lisa A. Sokoloff, Past President 2006-2007.

In honor of Women's History Month, honor our foremothers by helping the next generation. I want to thank Rhonda DeMeo Shilling, who taught me reporting skills on one of my first jobs. I could never repay her generosity but I can and I do emulate her. One of the Women's Bar's most important functions is mentoring. You don't have to be a member of one of our famous mentoring circles to be a mentor. I urge all of you to help another woman this year to learn a skill, avoid a pitfall, or make a better career choice.

Christina Kallas was President of NYWBA in 2005 - 2006, having served for many years before on the Board, as an Officer, and as a Co-Chair of the Technology and ADR Committees. She served WBAS-NY as Co-chair of the International Women's Rights Committee. She has served on the Board of our Foundation since 2005.

One woman who inspired me was my maternal grandmother. She came to the US in 1912 as a nineteen-year-old, from a small village in the Peloponnese, Greece, about an hour outside Sparta. Her father thought it was a waste of time to send a girl to school, so she was prevailed upon to enter into an arranged marriage with my grandfather, who was from the next village over. She met him for the first time on the day before their wedding, having just arrived in this country, and gave birth to her first child exactly nine months to the day after her wedding. She spoke no English when she arrived in the States, yet managed to raise five children here in NYC. She made all her sons' suits, gave a sumptuous repast each year in honor of her husband's Name Day, and stretched the food budget during the Great Depression so that no one in her family went hungry. She went to school at the age of 65, and learned to read and write English. She survived long enough to see me graduate from the 6th grade as valedictorian. Knowing how precious an education was to her, it was a very special day. The education that she was unable to obtain is a cherished gift for me. I am proud that I have been able to help to provide education to women, in part through our NYWBA continuing education programs and our NYWBA Foundation grants.

Scandalous Secrets of the Metropolitan Museum By Christine Carballo

On a brisk November Saturday morning, NYWBA members and their guests met in the lobby of the Metropolitan Museum, excited to begin the “*Scandalous Secrets of the Metropolitan Museum*” tour sponsored by the *NYWBA Events Committee*. Our tour guide was the charming *Professor Andrew Lear*, founder of *Shady Ladies Tours*. He led us on a journey through works of art having a scandalous backstory that often is unknown by the general public. Professor Lear’s tour was filled with humor and insight. One of the highlights of the tour was the infamous portrait of *Madame X* by John Singer Sargent. The portrait of the beautiful, and somewhat notorious, American born wife of French banker Pierre Gautreau is now considered an iconic work. However, it scandalized viewers when it was exhibited in the Paris Salon of 1884, causing considerable damage in the short-term to Sargent’s reputation, as well as to the reputation of Mme. Gautreau, whose identity was apparent to all despite the “Madame X” title. The group discussed how a simple slipped strap (in the original version of the work) or a woman’s bare shoulder scandalized society at the time. Professor Lear skillfully led the group, a nice mix of art connoisseurs and first time museum visitors, and everyone had a great time. At the conclusion of the tour, some members of the group headed off for lunch, to continue the discussion while enjoying a delicious Italian meal. The Events Committee is planning to sponsor another such tour in the near future!

Sheila Abdus-Salaam and the **Hon. Betty Weinberg Ellerin**, each of whom is a role model and graced so many of our events. Judge Ellerin remains a vital and active advocate for equality and a beloved mentor to so many colleagues.

The NYWBA has a wonderful history of extraordinary founders and leaders who contributed so much to our Association, to the practice of law and to our City. As such, I have asked our Advisory Council members, who include past presidents and longtime board members, to share what and who have inspired them for Women's History Month. I am delighted to share some of their messages in this issue.

It should not be taken lightly that Women's History Month follows Black History Month. After all, many early Women's Rights activists got their experience, voice and inspiration as Abolitionists or Civil Rights Activists. We would also be remiss to ignore the intrinsic relationship between the fight for equal treatment based on gender, the plurality of gender expression, and the fight against racism. We have a long way to go in making sure our fight for women's rights is intersectional, and by that I mean, leaving no voice behind in acquiring our place in legal power. As **Audre Lorde** once said, "What woman here is so enamored of her own oppression that she cannot see the heel print upon another woman's face?" I urge you all to think about the influence we have as lawyers and to be fearless in the face of injustice, and make sure that we are uplifting all those around us. We should not stand for women (or anyone for that matter) who receive accolades in their professional career and don't truly use that platform to help those in need.

With this in mind, more and more it is our young members and friends who inspire me, with their energy, passion for the law, their impatience for change, who remind us that we need to lift each other up so we can all rise together.

There is one more person I think of and thank on this Women's History Month: my daughter, **Emma**, for always inspiring me, challenging me, always asking the right questions, sharing important words, and always refusing to accept injustice.

So let's all get woke and fight on, together.

**Reflections by Kathleen Wahl,
New York Women's Bar Association
Foundation Fellow at Safe Horizon**

Last summer, I served as the New York Women's Bar Association Foundation Fellow with **Safe Horizon's** Domestic Violence Law Project. Safe Horizon's mission is to provide support, prevent violence, and promote justice for victims of domestic crime and abuse, along with their families and communities. The Safe Horizon Domestic Violence Law Project provides legal assistance in custody, visitation, divorce, child support, and family offense proceedings in Manhattan, Brooklyn, Queens, Bronx, and Staten Island family courts. Before law school, I worked in a client-centered organization, and I missed that type of work. My goal at Safe Horizon was to resume my focus on individual clients, specifically to learn how to engage meaningfully and empathetically with women and children who had survived trauma and were navigating the New York City Family Court system.

Through my fellowship, I represented clients on the record in the family courts of all five New York City boroughs. I regularly conducted client interviews, participated in safety planning, and explained court processes. I provided legal information and conducted intake interviews through Safe Horizon's legal assistance help line. I also had the opportunity to prepare uncontested divorce documents, research and draft petitions, motions, memoranda of law, direct and cross examinations, closing statements and settlements, and engage in trial preparation including preparing witnesses for testimony and in custody, child support, divorce, and family offense proceedings. I learned about the intersection between family and immigration law and the legal processes for divorce, child support, custody, and family offense cases. I also had many opportunities to help strategize for particular cases and to observe appearances and trials in family courts. In all of these activities, the training and supervision that staff attorneys provided me were invaluable.

While advocating for clients at Safe Horizon, I learned about the unique burden that a family court process places on parents and families. Clients told me about feeling re-traumatized when having to speak about their personal and familial relationships in court and in having family court judges and the Administration for Children's Services case workers analyze and opine on the most intimate parts of their lives. It was a privilege to help domestic violence survivors navigate the deeply challenging legal issues in their lives and achieve some degree of empowerment.

I would like to thank the NYWBA Foundation for the opportunity to work with the Safe Horizon Domestic Violence Law Project. What I learned about the special challenges that families face in family court proceedings has inspired me to delve deeper into family law by defending parents through The Bronx Defenders Family Defense Practice for my upcoming summer internship.
