PRESIDENT'S MESSAGE

Happy New Year! Let's face it, most of us are probably glad to put 2020 behind us and look forward to a year we hope will bring better news than the last. While 2020 saw its share of tragedies and setbacks, it also brought innovation in delivery of services by the court system and bar associations around the country. The challenges of the pandemic also could not





extinguish efforts to shine a light on important issues of Amanda B. Norejko

justice and equality. Building upon the foundations of our past, the NYWBA will have many opportunities to be a force for positive change in 2021.

In October 2020, a Report from the Special Advisor on Equal Justice in the New York State Courts was released. On June 9, 2020, in the midst of a national outcry about racial injustice. Jeh Johnson was appointed by Chief Judge Janet DiFiore to conduct a review of racial bias in the New York State Court System. To prepare the report, Mr. Johnson's team interviewed current or former judges, court clerks, court watchers, court officers, court attorneys and administrative personnel, private civil and criminal practitioners, institutional and public defenders and prosecutors from around New York State. In addition, they engaged numerous bar associations, judicial associations, court employee unions, court reform organizations and affinity groups. The findings in the report revealed "an under-resourced, over-burdened New York State court system, the dehumanizing effect it has on litigants, and the disparate impact of all this on people of color." The report makes numerous recommendations, stating "this is a moment that demands a strong and pronounced rededication to equal justice under law by the New York State court system." The NYWBA, as a bar association dedicated to promoting the fair and equal administration of justice, is steadfast in our commitment to fighting racial discrimination in the courts and increasing diversity and inclusion.

In November 2020, the New York Judicial Committee on Women in the Courts and its chair Hon. Betty Weinberg Ellerin (NYWBA Past President 1969-1970) released the results of its Gender Survey 2020, a comprehensive report on the results of a statewide survey on gender bias in the courts. The survey was an update to a similar study on gender discrimination that was completed in 1986 by the New York Task Force on Women in the Courts. More than 5,300 attorneys responded to the 2020 online survey, which included issues such as sexual harassment; child care; treatment of domestic violence, rape, and prostitution cases; and court appointments for women attorneys. The survey found that while advancements have been made, women still face higher levels of sexual harassment than men and are often viewed as less credible. Women reported that while there has been great improvement system-wide, there is still significant bias against women attorneys and litigants. The report contained recommendations for court administration, judges and quasi-judicial personnel, court clerks, law enforcement, lawyers, bar associations, law schools, legislators, and attorney disciplinary committees to address the gender bias issues indicated by the survey. As a bar association whose core mission includes promoting advancement of the status of women in the legal profession, the NYWBA will review thoroughly the results and recommendations of the Gender Survey 2020 and continue its efforts to raise awareness and address gender discrimination in the court system.

On December 8, 2020, the NYWBA launched the new Guardianship Diversity Initiative (GDI). The idea for this groundbreaking new program came from *Hon. Lisa A. Sokoloff*. Judge Sokoloff recognized the need to diversify the pool of attorneys eligible for court appointments as court evaluators, attorneys for allegedly incapacitated persons, and guardians in Article 81 guardianships. GDI includes a mentoring component to pair attorneys new to the practice with experienced volunteer mentors.

The NYWBA thanks the New York County guardianship judges: *Hon. Ta-Tanisha James, Hon. Mary V. Rosado, Hon. Carol Sharpe* and *Hon. Lisa A. Sokoloff* for sharing their insights at the hugely successful launch event. January is Human Trafficking Awareness month. In December, our newlyestablished Human Trafficking Committee hosted a powerful event at which members heard from a trafficking survivor and a long-time international human rights attorney. I first began working on the issue of sex trafficking in January 1999, and had the opportunity to engage in both direct service to victims and policy advocacy at the state, national, and international levels until joining the court system in 2018. It was inspiring to work alongside the survivor leaders who fiercely advocate for laws and resources to abolish this atrocity. Recognition of this issue by our state courts has been incremental, but thanks to the efforts of survivors and other advocates, more effective strategies to combat human trafficking continue to evolve. The NYWBA began its concerted efforts to bring attention to this issue under the leadership of **Deborah G. Rosenthal** (NYWBA President 2016-2017). In January 2017, the NYWBA co-hosted a CLE panel with Proskauer Rose LLP at which we first introduced many of our members to the realities of human trafficking and the legal frameworks to address it. So, I am pleased that WBASNY has taken up the cause of support for the Equality Model for combating human trafficking as a legislative priority for 2021.

In order to uphold our strong voice at the statewide level on these issues and others of critical importance to our mission, it is imperative that we maintain our NYWBA membership. The number of delegates who represent us on the WBASNY Board of Directors is directly related to the size of our membership. Our ability to fulfill our mission depends upon a vibrant and diverse community of members. The NYWBA Board of Directors recognizes that the pandemic has caused many members to struggle economically and bar association dues may pose a more significant barrier this year than in the past. We don't want to lose the important voices of our colleagues due to adverse financial circumstances of historic proportions. Therefore, the NYWBA membership dues will be reduced for anyone who renews their membership or joins as a new member before the end of this month. Guardianship Diversity Initiative

The Elder Law and Disabilities, Diversity, LGBT, and the Solo & Small Firm Committees of the New York Women's Bar Association were happy to partner with *The Franklin H. Williams Judicial Commission* to host the *Guardianship Diversity Initiative* by Zoom call on December 8th at 5:00 p.m.

We first would like to thank the Judges who joined us to share their insights and wisdom and to encourage the participants to join the guardianship bar and to become involved in Article 81 proceedings: *Hon. Ta-Tanisha James, Hon. Mary V. Rosado, Hon. Carol Sharpe,* and *Hon. Lisa A. Sokoloff.*

A big thanks is also due to our co-sponsors: The Women's Bar Association of New York, Armenian Bar Association, Asian American Bar Association of New York, Brehon Law Society of New York, Dominican Bar Association, Hispanic National Bar Association, Korean American Lawyer Association, and New York City Bar Association Diversity Equity & Inclusion Committee. The program would not have been a success without you.

We had over 70 participants for this event, which was a terrific turnout. The Guardianship Diversity Initiative was created to encourage attorneys and others who are interested in guardianship work to take on at least one of the Part 36 roles of Court Evaluator, Court Appointed Attorney or Guardian.



Judge Sokoloff introduced the project and highlighted the need for a diverse group of practitioners in our work. She encouraged participation in guardianship cases as a meaningful way to practice one's profession and to make a difference in the community at the same time. She offered to

allow attorneys new to guardianship who wish to observe a guardianship hearing, the valuable opportunity to do so. This offer was echoed by the other jurists.

Judge Rosado described her extensive background in guardianship and housing law, which has been invaluable to her work as a Guardianship Judge. She underscored the need for new practitioners in this area, given the busy Guardianship Court calendar and the needs of so many who are



suffering in the COVID-19 pandemic. Judge Rosado reminded the group that those with cases before her should notify her of important issues that require judicial intervention, in a timely fashion. She also offered excellent advice, to reach out to your peers for help and support.



Judge James gave us her perspective on the unique, combined housing and guardianship part over which she presides. This part handles cases where a guardian may need to be appointed, due to critical housing issues, such as failure to pay rent or hoarding problems. She remarked that she

has enjoyed the collegiality of the guardianship bar as well as the interesting nature of the cases before her, particularly since there are so many diverse and accomplished individuals presenting with guardianship needs in New York.

The newest of our Guardianship Judges, Hon. Carol Sharpe, introduced herself to the group. We are so pleased to have her on the roster of Guardianship Judges. She expressed her support for those persons doing the difficult work of guardianship, having been a litigator, herself. She




encouraged participation in the guardianship bar, telling us that there is always much to learn about guardianship law and that it is a good field in which to practice. On the issue of diversity, she noted that she recently had to locate a Hungarian-speaking attorney for one of the parties appearing before her.

After a short question and answer session, our Zoom meeting ended, but not before we were able to share some thoughts and ideas on pressing issues, such as how important financial records may be expeditiously collected, prior to the guardianship hearing.

As a part of our Diversity Initiative, the Elder Law and Disabilities Committee has committed to provide a mentor for anyone who is new to guardianship work and feels it would be helpful to reach out for advice and support. All you have to do is ask.

To conclude, we have another Zoom call scheduled for January 27th at 1 pm, at which Judge James and her Court Attorney, Ashley Lane-Nwokocha, will be presenting on the work that is done in Judge James' Guardianship Part. This program will be a joint effort of the Civil Courts Committee and the Elder Law and Disabilities Committee. We invite you to attend.

First Virtual Induction Ceremony Held in New York State By Sabrina E. Morrissey

Hon. Bianka Perez has been my friend for 13 years. She was sworn in as a Supreme Court Justice on December 10th in what was the first virtual induction ceremony in New York by Zoom call. I am so happy for her, and I know she will be a terrific Justice in Bronx County.



Since 2017, Judge Perez has presided in the Civil Court of Bronx County. Prior to her first election, Judge Perez was a sole practitioner. She was Bronx Democratic Commissioner of the New York City Board of Elections from September 2014 through June 2016 and was elected the first Latina President of the New York City Board of Elections in January 2016. She also served as Administrative Law Judge with the Office of Administrative Trials and Hearing from 2012 to 2014. She served as President of the Dominican Bar Association in 2012 and 2013 and was the Parliamentarian of the Bronx Democratic County Committee from 2012 to 2014. Judge Perez graduated from New York Law School in 2000.

There were many dignitaries in attendance for the December 10 ceremony. Among them were Presiding Justice Rolando T. Acosta, who administered the oath of office.

How did Judge Perez and I meet? Where else, but in a Courtroom? I was Petitioner's counsel in a guardianship case, and Judge Perez was appointed as Court Evaluator. I will never forget the difficulty she had, traveling to 60 Centre Street for several court appearances before Hon. Milton A. Tingling. You see, Judge Perez was very pregnant with her third daughter, Gabriella. Despite the difficulty, Judge Perez showed up and did her job well. I remember even now how serious and calm she was. She really made a strong impression on me.

Judge Perez, not surprisingly, has made a similar impression on many others. The Zoom call was maxed out, with the overflow crowd watching the ceremony as it livestreamed on Facebook, through the efforts of the Dominican Bar Association.

I wish Judge Perez many wonderful years on the bench, and I am so pleased that I was able to witness her induction ceremony. Judge Perez proudly wore her Justice Ruth Bader Ginsberg pin. In keeping with Justice Ginsberg's philosophy, Judge Perez said, "I do this for my daughters, and for all of the little girls who need to see that this is possible for their lives, and that hard work does pay off."

Getting Organized in the New Year By Sabrina and Jim Morrissey

With so much chaos and uncertainty in 2020, it may be hard to shift focus to practical ideas and organization in 2021. Here are a few ways to put things in order in the new year.

To start, make sure beneficiary designations are correct. Many people think they know who their beneficiaries are, but when they look, the names are not who they thought. If beneficiary designations are not readily available for bank accounts, insurance policies and pension benefits, call the company or ask a financial advisor or insurance agent for help in getting duplicate copies of designations. Review them, make any changes and keep copies with your valuable papers.



Review the riders attached to the homeowner's policy. Has a valuable item been acquired that is not included on the insurance rider, or has an item been disposed of that is still insured?

Review car insurance for SUM, APIP and OBEL coverage. These three plans supercharge car insurance and provide additional reimbursements. APIP is "Additional Personal Injury Protection," which adds more coverage for medical expenses, lost wages, and out-of-pocket expenses in \$50,000 increments. OBEL or "Optional Basic Economic Loss" coverage provides \$25,000 in additional reimbursement to cover pecuniary losses, once No-Fault coverage is exhausted. SUM, "Supplementary Uninsured/underinsured Motorist," coverage pays more than the mandatory minimum, which is added to PIP coverage.

Finally, consider purchasing disability and/or long-term care insurance. These are important policies, which can make a big difference in quality of life in the event of an illness, accident or age-related decline. As we grow older, long-term care insurance, in particular, can make it possible for us to remain in our homes (with care), as opposed to living in a facility. It is that important.

We hope these ideas will prove useful to all of you in having a much better year in 2021!

Cooking with NYWBA Chewiest Chocolate Chip Cookies Recipe by Jennifer P. Brown

In the Jewish tradition, we always have something sweet for the New Year to symbolize a sweet year to come. After 2020, we can really use a sweet year. So, in that vein, I give you my recipe for the chewiest chocolate chip cookies. This recipe makes big

cookies that are crisp on the edges and chewy in the middle. I like to keep them in the freezer and eat them slightly frozen for a real chewy treat.

Ingredients

- 2 2/3 cup all-purpose flour
- 1 1/4 tsp baking soda
- 1 tsp salt
- 1 cup softened butter
- 1 cup packed light brown sugar
- 3/4 cup sugar
- 2 large eggs room temperature
- 2 tsp vanilla extract
- 1 10 oz package mini chocolate chips

Directions

Whisk together flour, baking soda, and salt in a bowl and set aside.

Using a stand mixer with the paddle attachment, cream butter and sugars together.

Beat in eggs one at a time and add the vanilla.

Slowly add in the dry ingredients.

Mix in chocolate chips.

Shape 1/4 cupfuls of dough into balls and then flatten each ball into a 3/4 inch disk.

Place the dough disks in an airtight container, separating layers with wax paper.

Refrigerate overnight.

To bake, place dough disks 2" apart on a parchment lined baking sheets. Allow to stand for 30 minutes before baking. Preheat oven to 400 degrees.

Bake cookies until edges are golden brown, about 10 - 12 minutes. If baking two sheets at a time, switch sheet placement halfway through baking.

Allow to cool in the pans for 2 minutes.

Remove to a wire rack to finish cooling.
