If your work life has left you hungry for something a little different, on February 9th, the WBASNY Wellness Committee is presenting a cooking class with our own NYWBA Past President *Jennifer P. Jennifer is the author of a cookbook, *An Attorney's Journey Through Quarantine As An At Home Chef.*

February is Black History Month, which was established to honor and celebrate the contributions of African Americans to United States history. As someone who loves law and history, I use this month as an occasion to learn about some of the incredible stories of Black women who have shaped our legal system in the past and present, particularly those with a connection to New York.

One trailblazer in our legal system was Jane Bolin, who was born in Poughkeepsie, New York in 1908. Although she was strongly discouraged from applying to law school due to her sex and race, she was admitted and graduated from Yale Law School in 1931 as the first black woman to receive a law degree from Yale. In 1939, Mayor Fiorello La Guardia appointed Bolin as a judge of the New York City Domestic Relations Court, making her the first Black woman to serve as a judge in the United States. She was the only Black female judge in the country for the next twenty years. She served as a judge for 40 years until her retirement. Her contributions to our NYC Family Courts include encouraging racially integrated child services, ensuring that publicly-funded childcare agencies accepted children without regard to ethnic background.

A Black woman still making an impact today is Loretta Lynch, who began her legal career as a litigation association in New York City and eventually was nominated by President Bill Clinton to serve as U.S. Attorney for the Eastern District of New York. In 2011, she left the U.S. Attorney's Office to become a partner at Hogan & Hartson. In 2010, President Barack Obama nominated her to once again serve as U.S. Attorney for the Eastern District of New York, and then in 2014, as U.S. Attorney General. She was the first Black woman to (and second Black person) to hold this office. She is now a partner at Paul, Weiss and has been named one of Benchmark Litigation's "Top 250 Women in Litigation." In January 2022, she was part of litigation team from Paul, Weiss that filed an amicus brief on behalf of 86 businesses spanning every sector of the U.S. economy in support of the effort by the attorneys general of Virginia, Nevada, and Illinois to compel the National Archivist to certify and incorporate the Equal Rights Amendment into the U.S. Constitution. The amici argue that "eliminating systemic barriers that impede women's economic and social advancement will result in a more just, vibrant and productive America. Ratification of the ERA sends a powerful message about the nation's commitment to sex equality-a message amici believe would be transformational for the American economy." They also argue that the D.C. district court's dismissal in March 2021 on grounds that the three states ratified the ERA years too late "effectively turns back progress made over many decades in the struggle for women's Constitutional equality and closes the doors of the courthouse to Appellant States who seek a remedy for the Archivist's unlawful refusal to recognize their ratifications."

Estate Planning Practice Tip: Beneficiary Designations © 2022 by Antonia J. Martinez

Few clients understand that proper beneficiary designations can be as important as a well drafted Last Will and Testament. Without the help of a lawyer, many clients overlook their non-probate assets and assume everything they own will pass through their Will. When clients seek to update a Will, set them straight on this confusing aspect of estate planning and remind them about the distinction between probate and non-probate assets.

Probate assets are titled in one's individual name and upon death pass through the client's estate pursuant to a Will. These assets require that the fiduciary, usually a relative of the deceased, petition the Surrogate's Court in the county of the decedent's residence and seek authority for access to the estate assets. This takes time, during which the assets are unavailable to pay bills and depending on the court's backlog, can take months to process. At the height of the pandemic in the spring of 2020, decedent's daughter, discovered that she could not hire a realtor to sell her mother/father's house because the court had not officially named her executor. Without the appointment by the court, the daughter could not legally enter into a contract on the estate's behalf.

Non-probate assets do NOT undergo the probate process and pass automatically by operation of law upon presentation of a death certificate. Nonprobate assets can include IRAs, life insurance policies, annuities, brokerage accounts with a Transfer on Death designation, bank accounts with a Payable on Death designation, certificates of deposit, jointly owned real estate and/or jointly held accounts.

Practice Tip:

In preparing an estate plan, review each individual non-probate asset owned by your client. Obtain a copy of the current beneficiary designation on file at the financial institution where funds are held and make sure the beneficiary designation is consistent with your client's current wishes. When making changes to a beneficiary designation form, follow up with the financial institution and request written confirmation of the change. Additionally, if accounts are held jointly, obtain a copy of how each asset is currently titled. Regarding title to real estate, review the deed and if your client owns a cooperative apartment, obtain a copy of the Certificate of Shares to distinguish between a tenancy in common and joint tenancy with rights of survivorship. Where property is owned as a tenancy in common, each joint owner can pass the interest through the estate whereas a joint tenancy with rights of survivorship passes by operation of law to the surviving joint owner.

Clients typically believe if they have a Will, their estate planning is complete. It's up to estate planning attorneys to make things easier by thoroughly reviewing and assessing non-probate assets to ensure it is consistent with the client's overall goals.



Photographs of her with her beloved husband Marty and their children were juxtaposed with several of her early prominent cases as a litigator and her noteworthy Supreme Court opinions, reminding us all that she was a pioneer not only for women's rights but for all people's rights where there were inequities based on gender. One could not help but marvel at Marty's description of moving to Washington D.C. because his wife had gotten a "good job."

Last, but certainly not least, was the opportunity to see video footage of RBG acknowledging her moniker and how she came to be "Notorious," showing the humorous side of this remarkable woman.
